### **Reading of September 2016 meeting minutes:**

The September Minutes were written by Adjutant Pizarra and disseminated to the membership via the Hub-master, Paul Dudkowski and placed on the Post home website. Vice-Commander Phillip Malsbary made the motion to accept the minutes as sent by e-mail; Comrade Foland seconded the motion. The motion passed.

### **Finance Report:**

Comrade Jim McGuire read and presented the finance report. Comrade Foland made the motion to accept the report as read; Comrade Gonzalez seconded the motion. The motion passed.
