Who can get help

- I. You :
 - a. have served in the military, OR
 - b. are married to a veteran or are the surviving spouse of a veteran, OR
 - c. are the child or other dependent of a veteran and currently depend on the veteran for support.
2. Your legal problem is a civil (non-criminal) issue.
3. You live within LSLA 's service area(see list of counties on the back).
4. You meet income- and asset-based criteria. We serve people who have low incomes and limited assets.

3. Apply in person at one of our 13 offices. Be sure to tell them you are applying for help from the MVU. *Turn page over to find branch offices and walk-in times.*
4. We may ask you to give us a copy of the veteran's DD-214, a military or dependent ID card, or a VA Healthcare ID card to verify veteran connection or status. If you do not have a copy of the veteran's DD-214, we can help you get one for free.
